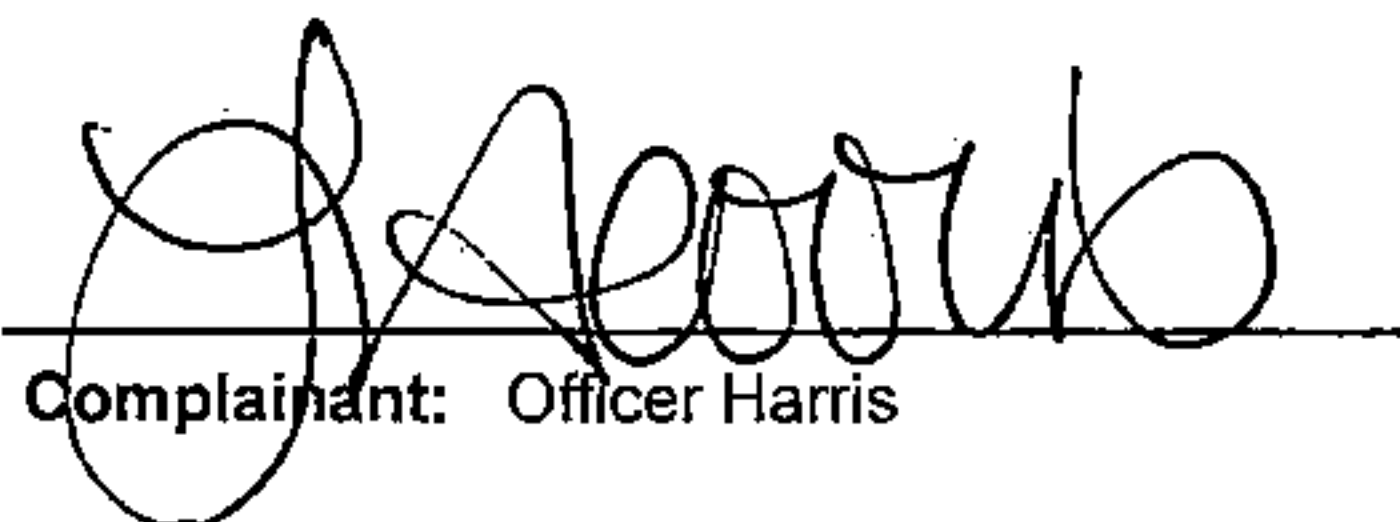

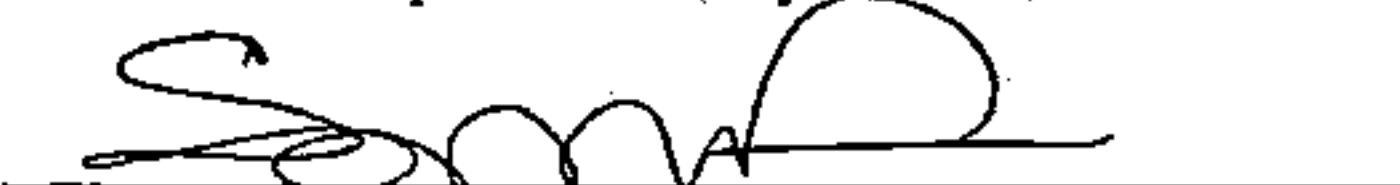

On 07/23/2025 at 0847 hours Officer Hammann and I were dispatched to _____ in reference to an assault. The caller, _____, advised dispatch _____, Noel Cedene, hit her in the face with his hand then left the home

Upon arriving on scene, officers utilized a translator via phone to speak with _____. She advised the following:

This morning she and _____ Mr. Cedene began to argue about Mr. Cedene having a girlfriend. The girlfriend called _____ this morning and the two began to verbally argue on the phone. This in turn led to an argumennt between Mr. Cedene and _____ then began to gather her belongings to leave the residence. It was at this time Mr. Cedene punched her several times on both sides of the face. The girlfriend then stated she would also beat up

While speaking with _____ Mr. Cedene arrived back home with _____. Again officers used a translator via phone to speak with Mr. Cedene. He advised the two began arguing yesterday around 0500 hours about the girlfriend. While Mr. Cedene was sleeping, _____ took his cell phone and began calling different women. Mr. Cedene denied ever striking

Officers observed a small area of redness on _____ left hand. When asked how she sustained this, she advised she was struck on the hand while attempting to block Mr. Cedene from continually striking her face.

When officers initially attempted to arrest Mr. Cedene, _____ began to cry and attempted to intervene while stating, 'no jail.' Mr. Cedene was successfully taken into custody at 0936 hours. _____ was given a verbal warning and advised if she continued to intervene she would also be arrested.

Mr. Cedene was taken to headquarters for paperwork and placed in the Clark County Jail for safekeeping.

Due to the language barrier, _____ was not able to sign her Marsy's Law Packet but was still provided a copy. Officer Hammann took photographs of _____ face and hand injury.
