The Affiant, Officer Harris , being first sworn, says there is probable cause to believe the defendant, Mikeena M Fitzgerald , committed an offense based on the summary of facts below:

Your Honor,

On 08/07/2025 at 0940 hours _____ an employee at Love's Truck Stop (1725 E. Ridge Road) called dispatch in reference to locating a firearm at the store here. _____ also advised there was a female currently here becoming agitated with staff. _____ believed the firearm belonged to the female. The firearm was currently secured in the office.

Sergeant Pergram, Sergeant Fredendall, Officer Matthews and myself responded. Sergeant Pergram and Sergeant Fredendall spoke with employees in the office while I spoke with the female, later identified as Mikeena M. Fitzgerald. Sergeant Pergram and Sergeant Fredendall observed the firearm to have one in the chamber and the magazine missing.

Ms. Fitzgerald advised she got off the bus here after the bus driver was being rude to her. Ms. Fitzgerald further stated she was trying to make her way to the state of Alabama. I asked Ms. Fitzgerald if there was a discrepancy about a firearm to which she replied it was not hers.

While inside, Sergeant Pergram and Sergeant Fredendall ran the firearm, a Springfield Armory XD 9MM (serial number _____). Clark County Combined Dispatch confirmed the firearm was stolen from the state of Indiana (Case Number 23057040). Ms. Fitzgerald was taken into custody at 1017 hours without incident. She was subsequently trespassed from Love's Truck Stop.

Ms. Fitzgerald's person and backpack were searched incident to arrest where a magazine containing eight 9MM rounds was located.

I spoke to _____ who advised the cashiers were notified by a customer there was a female in the back corner between the restrooms messing with a firearm. Due to the cashiers being afraid to approach the female, I _____ went to speak with her. _____ stated he saw the female, Ms. Fitzgerald, eject a round and then place the firearm on the ground. Ms. Fitzgerald then kept trying to pick the firearm and bullet back up while stating, 'it's not mine.' It was at this time _____ took possession of the firearm and took it to the employee office.

Sergeant Pergram and Sergeant Fredendall submitted the firearm under property receipt number 40479.

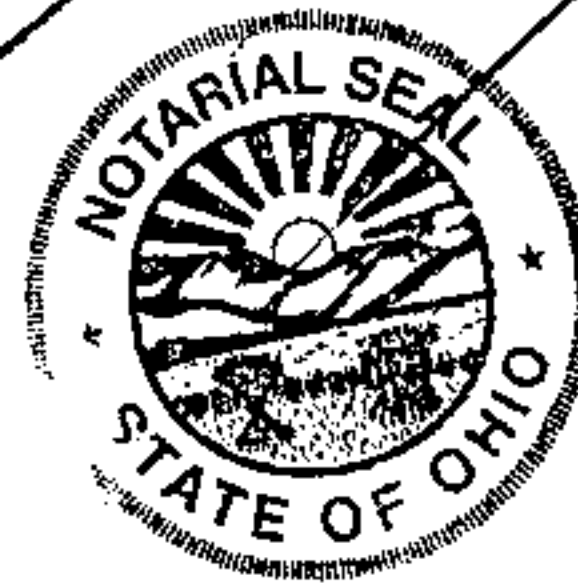
Ms. Fitzgerald was transported to police headquarters while officers completed paperwork. While I was speaking with Clark County Combined Dispatch on the phone regarding the serial number of the firearm, Ms. Fitzgerald made a spontaneous utterance of, "I unloaded it."

Mikeena M. Fitzgerald was taken to the Clark County Jail for safekeeping and charged with receiving stolen property. She was given a court date of 08/08/2025 at 1030 hours.
