The Affiant, Deputy Ryan Pennington , being first sworn, says there is probable cause to believe the defendant, Brentyn Lynn Stoops , committed an offense based on the summary of facts below:

BWCR

On August 17, 2025. at approximately 1618 hours. The Clark County Communication Center received a call from _____ wanting to report a protection order violation. _____ advised the call taker she has an active protection order against Brentyn Stoops and it was found that Mr. Stoops was currently at the address listed on the protection order. _____ requested to speak to a deputy via phone to see what her options were. Deputies responded at that time.

While speaking with _____ she advised that she had an order served to Mr. Stoops on the 11th day of August. She stated that she has been in the process of moving out of the home and that she was not present at the address. _____ advised she was contacted by her _____, _____ advising Mr. Stoops was at the address moving sheep into a livestock trailer requested to know what her options were due to Mr. Stoops not being allowed on the property. While speaking with _____ she had also made the notion that Mr. Stoops attorney had been in contact and a deal was being made for when _____ leaves the address completely; Mr. Stoops could take back ownership of the home.

_____ advised that she was in the process of moving but has not completely vacated the address and she and Mr. Stoops are due in court regarding the protection order on Monday August 18, 2025. _____ was advised that Deputies would respond to the _____ address and attempt to make contact with Mr. Stoops and she would be updated on the investigation. Deputies responded at that time.

When I arrived on scene, Mr. Stoops was no longer on scene. While checking the property, a neighbor arrived and advised he had also seen Mr. Stoops on the property. The _____ advised earlier in the evening the sheep had gotten out of the fence on the property. Aware of the current legal process between Mr. Stoops and Mrs. Stephens he advised he didn't call but saw Mr. Stoops had arrived on the property and began moving trailers and the sheep. While _____ filled out his statement, I made contact with the original reporting party to

_____ advised she heard a lot of commotion outside around 4:00pm. When she looked outside she had seen multiple vehicles parked on the north side of the road in front of the property. While observing the occupants it had appeared the sheep had gotten out of the fence. _____ stated she observed Mr. Stoops putting one of the sheep in the trailer and taking it up the road then returning to the property and back by the barn. She advised Mr. Stoops began unhooking the trailer and shortly after had left.

While gathering _____ Statement she was also able to provide photos of Mr. Stoops on the

property via Axon Community Request. Deputies obtained [redacted] Statement and made contact with [redacted] who arrived shortly after. [redacted] provided a statement regarding the events and also mentioned previous violations. [redacted] advised Mr. Stoops grandmother had text and called her a few days prior requesting mail and bills on behalf of Mr. Stoops. [redacted] stated she didn't respond. After not responding, at some point Mr. Stoops grandmother went into the address and gathered his mail and other belongings without [redacted] permission.

[redacted] advised that since the protection order has been in place, she has been harassed by Mr. Stoops family and is ready for it to end. While looking at the protection order that was served to Mr. Stoops it provided key points in the order advising that the petitioner [redacted] had exclusive possession of the residence located at the [redacted] address. It further stated that the respondent is forced to vacate the property as well as not enter or interfere with the residence as well as other property on the residence.

Mr. Stoops was contacted via phone to attempt getting his summary of events in which he refused to speak on the incident. Mr. Stoops at one point advised that he would get it all straightened out at court the following day. [redacted] was advised that due to not being able to locate Mr. Stoops charges would be submitted and a warrant would be requested. [redacted] was further advised that per the order Mr. Stoops was aware he wasn't suppose to enter the property without deputies present within the time allotted in the order. Although she believed it was "petty" it was also advised per the order Mr. Stoops is not suppose to have third party contact on his behalf with [redacted]. It was clear Mr. Stoops coming to the property multiple times and having people contact [redacted] he was blatantly disregarding the order set in place.

[redacted] was provided with a domestic violence resource packet and walked through a domestic violence lethality screening and strangulation worksheet. [redacted] advised the information was not applicable and signed the forms advising such. [redacted] statement was obtained.

Charges and a warrant will be submitted for Mr. Stoops reference violation of ORC 2919.27 Violating a protection order. Mr. Stoops made third party contact with [redacted] as well as entering the property/residence listed in the order. Deputies cleared the scene with a report.

Prior to this incident, Brentyn's grandma contacted me via text & called & left a voicemail about needing to pick up bills at the house, so Brentyn could pay them. I didn't respond. His cousin Chasidy Bayless texted me harassing me about taking things out of the house & questioning me about my integrity about what happened a couple Fridays ago when he threatened my life & put my daughter in harm's way. Brentyn's grandma went inside the house, without my permission & told Brentyn I took his checkbook. I did not take any of his belongings. Him & his family have violated the protection order multiple times.
