On arrival, Officers spoke to the caller and victim; I stated that he just got back home from vacation and came to this address to check on his When walking into the back door, he witnessed his Marcus Dearmond, screaming over their and arguing. asked what was going on and this is when Mr. M. Dearmond picked up a brick and threw the brick at hitting him in the upper left ribs. When inspecting ribs, there was an apparent red spot with discoloration in the area where he stated he was hit with the brick. After hitting with the brick, Mr. M. Dearmond fled the area, last seen wearing a blue tank top and jean shorts. Officers checked the area for Mr. M. Dearmond but was unable to locate him.

Officer E. Taylor photographed the victim's injury as well as the brick used in the assault.

Due to the above statement, warrants are requested for Marcus Dearmond for Domestic Violence and Assault.


