The Affiant, Officer Oates, being first sworn, says there is probable cause to believe the defendant, Paul R. Kasten, committed an offense based on the summary of facts below:

On August 15th, 2025, at 1714 hours, I, Officer R. Oates, and Officer S. Rofe were dispatched to _____ in reference to an assault that took place at 1513 hours.

Upon arrival, Officers made contact with the victim and reporting party, _____ explained she lives across the street from Paul and Susanne Kasten. Ms. Kasten has multiple medical issues and can not care for herself, so she helps take care of her. Earlier in the day, the entire street had lost power for a short while and Ms. Kasten was sitting in an electric recliner. With the power being out, she could not put the legs of the chair down so she could get up to use the restroom. _____ knew of this and went to assist Ms. Kasten. However, _____ herself has medical issues and could not lift Ms. Kasten by herself. When _____ asked where Mr. Kasten was, Ms. Kasten explained he had gone to the scrap yard to scrap metal he had collected. _____ went out to look for him and found him at _____ and tried to explain the situation.

By the time Mr. Kasten had returned the power had been restored and Ms. Kasten was able to move her chair. However, Mr. Kasten again tried to leave and an argument ensued between Mr. Kasten and _____. _____ told him if he left the house, she was going to call the cops because she knew he had been doing drugs and was under the influence. _____ stated Mr. Kasten returned from the front door, and started to scream "fuck you" over and over, spitting in the process. Afraid things would escalate, _____ attempted to call 911. Mr. Kasten reached for her phone, and grabbed her right wrist in the process, causing minor injury to her right thumb. _____ was not able to call 911 due to him attempting to grab her phone away from her. After some time of arguing, _____ explained Mr. Kasten threw clothes of different material at her, hitting her in the face. She stated her face was red from the clothes, however, there was no redness seen during the interaction.

After Mr. Kasten threw the clothes, he proceeded to walk out the door and leave in a white Nissan Pathfinder license plate KFZ9387, which is registered to him.

_____ filled out a written statement on scene, and photos of her injuries were taken.

After speaking with _____, Officers then spoke with Ms. Kasten. She stated she was sitting in her chair, when the power went out earlier in the morning. Being her chair is electric she could not move the legs of the chair to go use the restroom. She called Mr. Kasten to try and figure out where he was and if he could come back home and assist her in getting to the restroom. Ms. Kasten stated while on the phone, Mr. Kasten told her "you can sit in your own shit until I get back." Shortly after _____ came over to check on her. She explained the situation to _____ went to go look for Mr. Kasten. Upon his arrival, Mr. Kasten, and _____ got into an argument. Mr. Kasten went to leave and _____ told him, she would call the cops if he left the house. That's when Mr. Kasten walked back to _____ and started to scream in her face. He also attempted to grab _____

phone from her, scratching and twisting her arm in the process. After Mr. Kasten was unable to get the phone, he threw clothes at her hitting her in the face. He then walked out the front door and drove off in his truck.

After speaking with both parties on scene, Officers attempted to locate Mr. Kasten at [redacted] to get his side of the story. Upon arrival to the address, there was an elderly male who answered and stated he had not seen Mr. Kasten in a while and did not know where he went nor when he would return.

Given the evidence on scene, as well as cooperating victim and witness statements, warrants are being requested on Mr. Kasten for one count of Assault, and one count of Disrupting Public Services.
