JOHNSON who being duly sworn states that on or about August 22, 2025, one DONTA' GREEN In the City of Springfield, County of Clark, State of Ohio did:
by force, stealth, or deception, trespass in an occupied structure, or in a separately secured or separately occupied portion of an occupied structure, when another person other than an accomplice of the offender is present, with purpose to commit in the structure or in the separately secured or separately occupied portion of the structure any criminal offense when the offender inflicts, or attempts or threatens to inflict physical harm on another.
