

The Affiant, Deputy Zacharia Storts , being first sworn, says there is probable cause to believe the defendant, Christopher A Domer , committed an offense based on the summary of facts below:

On 9/5/2025 a report from Sheetz Gas Station at 1751 Titus road was placed by employee Caitlyn Root about a man wearing a high visibility shirt that said "Clark County Maintenance LLC 937-977-4133" appearing to be impaired from some sort of substance. The man continued to act erratic "nod out". Root explained to me that she was alerted by several customers about this man. This was nearing lunch time and upon my arrival the store was busy.

Prior to my arrival Springfield City Police were not available so myself and Ohio Highway State Patrol were advised just incase the man drove off. No county vehicles were in the lot and the number also on the shirt belonged to a private business. The caller continued to state that the man was losing balance and near falling.

Upon my arrival, I located the man in question and was pointed out to him by customers and employees of the store. I watched the man for a brief moment try to put lottery ticket in the lottery machine, he had difficulties with this, maintaining his balance, and he appeared to be talking to himself. The man had a hard time keeping his eyes open and he fumbles with his wallet , he also had some of his cash openly sitting on a counter next to the lottery machine.

I made myself visible to the man and identified him by his Ohio ID "RS496759" and asked if he had medical issues. The man, Christopher Allen Domer, advised he does have some issues, but none that would make him lethargic and loose his balance. Domer made vague mentions about medical conditions and drug usage history / recovery history.


I asked Domer how he came here and he said he is on a job with his driver doing stump grinding and property cleaning, his driver Seth Hannah. Seth assisted Domer to the work truck and I obtained contact information for the two men's employer, Mr. Gary Lockwood. Trooper Sherrod arrived on scene and asked Domer if he had ingested anything or if he is on prescription medications? Domer eventually admitted to suboxone use earlier today.


Lockwood was advised to meet at the job site at 5549 Beard Road to pick up his employee. Lockwood arrived and relieved Domer of employment and removed him from the jobsite without incident. During that process Domer was served an order in summons for disorderly conduct and advised to appear at Municipal Court 9/10/2025 at 1030 hours. Lockwood said that when Domer arrived to pick up equipment Domer was not intoxicated, Lockwood believes Domer used some time after picking up the equipment. Domer did not have anything on his person.
