The Affiant, Officer Huxley , being first sworn, says there is probable cause to believe the defendant, Lena L Reed , committed an offense based on the summary of facts below:

On 10/09/2025 at approximately 2346 hours, Officers Young and Huxley responded to :
St. in reference to a domestic.

Upon arrival, Officers met with _____ (victim) on the porch. Officer Huxley spoke with _____ while Officer Young went inside to speak to other involved parties. _____ advised that she had been sitting in the living room with her cousin, Patricia Hilliard (witness). _____ and Ms. Hilliard were talking about a boyfriend that _____ has that her mother, Lena Reed (defendant), does not like. Ms. _____ stated that Ms. Reed then came into the living room and got into _____ face. Ms. Reed then pushed _____ and struck her on the forehead with a closed fist. _____ advised that she then tried to grab Ms. Reed to get her to stop, but Ms. Reed then swung at her again. _____ stated then her and Ms. Reed then went to the ground, breaking the glass top of a table.

Officer Young spoke with Lena Reed. She stated that her and her daughter, _____ were downstairs in the living room when they began arguing. Ms. Reed stated they began arguing about boyfriend, when things got physical between the two of them. Ms. Reed stated that _____ shoved her into a TV, causing her to fall to the ground. She stated while she was attempting to get back up, _____ pulled her hair, causing her to go back down to the ground. She stated Patricia Hilliard then broke the two up and she called the police.

Officer Young also spoke to Ms. Hilliard who advised that Ms. Reed was the aggressor and that she saw everything happen. Ms. Hilliard stated she was in the living room when Ms. Reed and _____ began arguing. She stated _____ sat down in a rocking chair in the living when Ms. Reed walked out of her bedroom and confronted _____ stood up and Ms. Reed then pushed her backwards. Ms. Hilliard stated she watched Ms. Reed attempt to punch _____ in the face. She advised the two individuals ended up on the ground in the living room. Ms. Hilliard advised Ms. Reed was attempting to push Ms. Hilliard off of her the whole time. Ms. Hilliard advised nobody threatened each other during this, and that the physical encounter only lasted about two minutes.

After speaking with all parties, Ms. Reed was placed in custody without incident and transported to the Clark County Jail. Ms. Reed is being charged with DV and Assault.

_____ advised that Ms. Reed has many health issues, including numerous medications, COPD, and she is missing all 10 of her toes, causing her to be partially disabled and be prone to infection. Ms. _____ wanted this documented to ensure she received adequate care while in the CCJ.
