



The Affiant, Officer C Taylor , being first sworn, says there is probable cause to believe the defendant, Shaun Lamar Caldwell , committed an offense based on the summary of facts below:

On 10/12/2025 at approximately 0329 hours I, Ofc. C. Taylor was dispatched to the address of in reference to a family member receiving threatening texts and calls.

Upon arrival I met with Lindsey Crystal Yoakem, the Ms. Yoakem advised she was woke up by her in regards to him receiving texts and calls from his going to harm him. I then spoke with who advised his goes on a drunken rant and acts this way and has done so in the past. advised this started when he was talkina with his Shaun Lamar Caldwell, via text about an upcoming football game three days ago. advised the conversation was going well but today he advised Mr. Caldwell randomly texted him and it seemed as if he was angry. The conversation continued and there was much back and fourth with no direct threats for much of the text history I observed however Mr. Caldwell did make a statement via text that stated Mr. Caldwell was going to knockout then advised he had screen recordings from the calls he just had with his and this is where the majority of the threats were made and indirect threats as well. Mr. Caldwell made very vulgar statements for much of the call between him and Mr. Caldwell stated "you can die", "I'm going to beat the shit out of you", "I'm going to off you" and "I'm going to see you". advised a current address for Mr. Caldwell is 824 Hodapp Ave. Dayton, OH.

and Ms. Yoakem were both advised about the proper steps to take to proceed with getting a protection order if the wish to do so was given a case card and advised to send the recording of the phone call and screen shots of the text messages, after a short time did send the evidence via email.

Warrants are being requested for Shaun Lamar Caldwell for Domestic Violence (c) and Agg. menacing.


