The Affiant, Officer Collin Matt, being first sworn, says there is probable cause to believe the defendant, Willquaun Johnquill Bratton, committed an offense based on the summary of facts below:

On Wednesday 10/15/2025 at approximately 2237 hours, Officer C. Matt and Officer Bartlam were dispatched to _____ in reference to an initial open line in which Dispatch overheard physical fighting. Dispatch received multiple calls from this location during this incident, one of the callers stated, "that her _____ assaulted their mother and her".

Upon arrival, Officer C. Matt observed a male wearing a white in color shirt fleeing the scene on foot through the backyard of _____. Officer C. Matt then made contact with two victims at the rear of the residence. The victims were identified as _____

Both victims were complaining of head injuries due to having been struck by the suspect, later identified as Mr. Willquaun Bratton. Mr. Willquaun Bratton is the _____ of _____ and a _____ of _____.

Medics were requested to the scene at this time. Officer C. Matt spoke with the victims in reference to the details of the incident. _____ stated Mr. Willquaun Bratton was in the residence being belligerent causing issues and slamming dishes in the sink while another family member was using the sink. _____ stated she told Mr. Willquaun Bratton he needed to leave at which time the two engaged in a verbal argument. _____ stated Mr. Willquaun Bratton was in her face and then struck her in the head with a closed fist. _____ stated she stepped back and threw an object at Mr. Willquaun Bratton in self defense and stated she was in and out of consciousness due to having been struck. _____ stated she observed her _____ be struck and attempted to intervene and stepped between _____ and Mr. Willquaun Bratton. _____ stated Mr. Willquaun Bratton then struck her in the head with a closed fist an unknown number of times causing her injury. Once Mr. Willquaun Bratton was aware the police had been contacted, he fled the scene on foot. Officer C. Matt did observe visible swelling to the left side of _____ head on scene. Medics arrived on scene and checked both victims. _____ was transported from the scene by Medics for further treatment/care. _____ completed written statements on scene for Officers.

Officer Bartlam spoke with a child witness (who will be referred to as CW1), who stated she observed _____ to be verbally arguing with Mr. Willquaun Bratton. CW1 stated _____ got within 5 feet of Mr. Willquaun Bratton and threw an unknown object at him striking him in the chest. CW1 stated Mr. Willquaun Bratton responded by throwing multiple closed fist strikes at _____. _____ attempted to strike him back. CW1 stated _____ stepped in the middle of the altercation and began swinging at Mr. Willquaun Bratton as well prior to Mr. Willquaun Bratton leaving the scene.

Officer C. Matt took photos of the scene and the victims' alleged injuries.

Warrants are being requested on Mr. Willquaun Bratton for two counts of Domestic Violence and two counts of Assault.
