

The Affiant, Officer C Schmidt , being first sworn, says there is probable cause to believe the defendant, Michael Ray Kirby , committed an offense based on the summary of facts below:

On October 20, 2025, at 2053 hours, Officer Schmidt and Officer Mitchell responded to Speedway, 1147 N Limestone St. in reference to a theft. Upon arrival, officers spoke with Lead CSR Andrea Rupert who advised a male came inside the store and took a 12 pack of Twisted Tea valued at \$16.99. He made no attempts to pay before leaving. Ms. Rupert was already at the entrance doors when the male walked past her, and she saw he had the tea with him. The male fled in a black PT Cruiser, OH registration KRT8228. The license plate came back to a black 2008 Chevrolet HHR, registered to _____ Ms. Rupert described the suspect as a white/bi racial male, red hair, approximately 6'00", 200lbs, wearing a tan hoodie and jeans.

At 2116 hours, officers responded to _____ where the suspect vehicle was located parked in front of the residence unoccupied. Officers knocked on the door and made contact with _____. After explaining why officers were there, _____ denied driving her vehicle or allowing anyone else to drive it. While speaking with her on the porch, officers located a male sitting on the couch in the living room. He could be seen from the front window due to the curtains being open. Officer Mitchell recognized this male due to a previous encounter with him. He was identified as Michael Kirby Jr. Officer Mitchell had previous knowledge of _____ having an active protection order against Mr. Kirby. Dispatch was able to confirm this. The protection order was served on September 15, 2025 by Deputy Weiss, court case number 25P0331. When the protection order was brought up to _____ she denied anyone being at the house with her, although she turned to look in his direction and ultimately closed the door on officers. Officers observed someone close the curtains more. As more officers arrived on scene, the lights to the residence turned off. Officer Bennett could hear Mr. Kirby and _____ arguing and _____ telling him to go outside. Officers spent an extended period of time knocking on the door and making several commands for Mr. Kirby to come outside. Officers also made several commands to _____ to open the door due to Mr. Kirby having an active warrant for theft as well, case number 25CRB02749. At one point, _____ yelled for officers to stop knocking on the door and music was turned on in the residence.

Due to there being an active protection order, protecting _____ from Mr. Kirby (resulting from a domestic), Officer Schmidt kicked the front door in and multiple officers responded inside to take Mr. Kirby into custody at 2151 hours. Once the door was open,

was standing at the top of the stairs and was given several commands to come downstairs with her hands up. complied and advised officers Mr. Kirby was upstairs. She was detained at 2151 hours. Officer Bennett, Officer Crone, Officer Mitchell and Officer Householder responded upstairs. Officer Crone walked into the middle bedroom and located a closet door which was closed. When he first tried to open the door, it wouldn't open. He attempted again and Mr. Kirby was located and initially complied by putting his hands up. Once he was ordered out of the closet, he was given several commands by officers to put his hands behind his back. Mr. Kirby began yelling at officers while pulling his arms away. Despite repeated commands to place his hands behind his back, he continued to yell and tense his arms, refusing to comply. Eventually, officers were able to get handcuffs on him and he was placed in custody at 2153 hours.

was placed in the back of a cruiser. Officer Schmidt read her Miranda Rights at 2158 hours. advised she did not give Mr. Kirby permission to drive her vehicle but she was aware he took her vehicle somewhere. When he returned, she admitted that he walked in with a pack of twisted teas but stated he was the only one drinking them. Officers located the open pack of twisted teas inside the room that Mr. Kirby was hiding in. There were multiple open cans scattered around the room.

was released and spoke with officers further advising she was not aware that Mr. Kirby had an active warrant nor was she aware the protection order was still in place. She stated Mr. Kirby came to her residence yesterday and has not left since. did not feel like she was being forced to stay inside her residence, but also stated Mr. Kirby told her to stay in the bedroom and to not open the door despite her repeated attempts to get him to leave willingly. She also admitted that he was the one who turned the music on.

Officer Crone took pictures of the damage to the front door as well as the twisted teas located in the upstairs bedroom.

Mr. Kirby is being charged with theft, obstructing official business, resisting arrest and violation of a protection order. He was transported and booked into the Clark County Jail. Mr. Kirby will have court on Tuesday, October 21, 2025, at 1030 hours.
