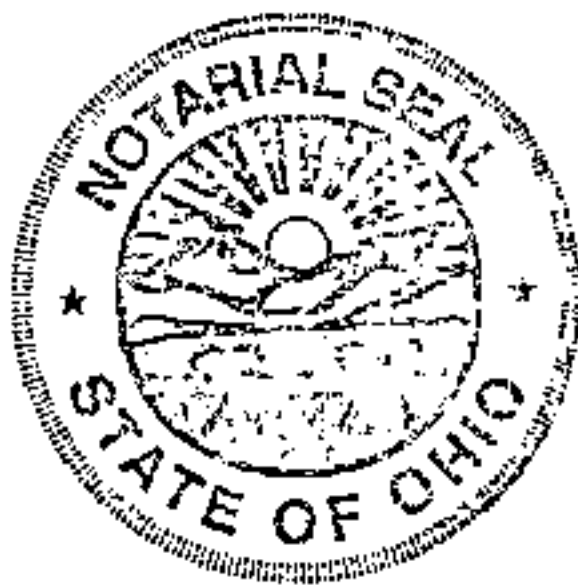

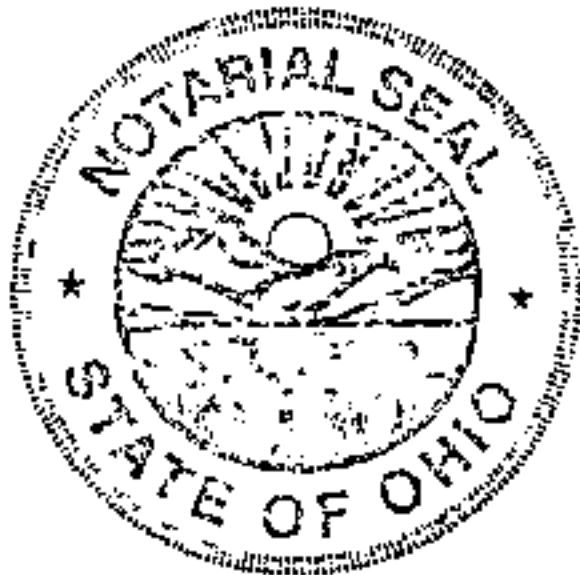



The Affiant, Officer G Mefford , being first sworn, says there is probable cause to believe the defendant, Zachary Jay Clouse , committed an offense based on the summary of facts below:

On 10/23/25 at 1837 hours, Officers were dispatched to _____ reference a domestic incident. While enroute, dispatch began receiving calls of a large group fighting in the parking lot.

Due to the reports of a male bleeding, Officers responded emergent. Officers Mefford and Hogan arrived on scene first and split up the crowd and began gathering info. Officer Hogan spoke to Zachary Clouse who had several bleeding facial injuries who reported he was assaulted by two males farther in the complex. Officer Mefford spoke with the caller, _____, and her mother, _____ in front of the address. _____ the neice of Mr. Clouse, was observed to have marks about her neck. She reported that everyone was at her apartment for a party when Zachary, who had been heavily drinking, choked her up against a wall causing the marks on her neck. At that time, her mother and mom's boyfriend, John Overman Sr, and another male, Damien Wise, told Zachary to leave. At that time, Zachary punched John leading to a brawl between John, Zachary, and Damien who was initially trying to break it up.

Outside, Zachary began kicking and punching both _____ vehicles causing significant dents about the body of both vehicles. The fight between the males continued outside where John and Zachary went down to the ground throwing punches. At that time, John suffered a dislocated left shoulder which was evaluated by medics. John, despite claiming he was assaulted first and witnessed by several, did not want to pursue charges. _____ both wanted to press charges for the incident in which _____ was choked, and for the damage to their vehicles.

Photos were taken of the marks around _____ neck, injuries to both Zachary and John, and the damages to both vehicles. Zachary was placed in custody and transported to SRMC for injuries sustained during the fight with Mr. Overman. Due to the injuries sustained, Zachary was transported to SRMC for scans and evaluation before being placed in custody. Once Zachary was informed of his charges, he told Officers he was "about to turn up" as he was escorted to the car. Once Officers arrived at the car, Zachary kicked both Officer Hogan and Mefford in their legs before being taken to the ground. Once calmed down, he stood up and refused to get in the cruiser before talking to a supervisor. Officers then had to forcibly place him in the car where he proceeded to bang his head numerous time, cutting his forehead. Zachary made several remarks about finding Officers and their family members once he got out. Zachary was transported with lights and sirens to the jail to prevent further harm to himself.

Zachary Clouse is being charged with Domestic Violence, Assault, Strangulation, Criminal Damaging, Assault on a Police Officer, and Resisting Arrest. Zachary has a prior conviction of F5 Assault out of Clark County (18CR0246) and has DNA on file in the offender database.


