



The Affiant, Officer G Mefford, being first sworn, says there is probable cause to believe the defendant, Emily Jean Everhart, committed an offense based on the summary of facts below:

On 11/6/25 at 2000 hours, Officers were dispatched to 1523 Kenton St reference a missing juvenile refusing to leave the residence.

Officers met with Jasmine Fudge who advised that her son, Deshaun Taylor, had been missing for approximately 2 weeks and she has had no contact with him. Ms. Fudge had seen a video going viral today showing her son getting out of a red Dodge Dodge Journey owned by Emily Everhart, who also appeared in video. In the video, Ms. Everhart could be heard telling Deshaun to "beat that bitch's ass." Upon seeing the video, Ms. Fudge did some follow up work of her own and found that Ms. Everhart lived at 1523 Kenton St. Once Ms. Fudge arrived, she observed her son in the upstairs window. Ms. Fudge knocked and got an answer from Ms. Everhart and several other juveniles. Ms Fudge advised that Ms. Everhart made some choice words and then shut the door and turned the lights off before Officers arrived.

Once on scene, Officers Fisher and Mefford spoke with Ms. Fudge and made contact with Ms. Everhart. Ms. Everhart was immediately uncooperative and refused to allow Officers to speak with her or anyone else inside. One of the juveniles in the home, was Mickalah Parker, was willing to speak with Officers to provide more info about Deshaun's whereabouts. While speaking with Mickalah, Emily began pulling on Mickalah refusing to allow her to speak with Officers. Emily was warned that Mickalah was a willing participant, at which time Emily slammed the door and began hurling insults. Mickalah attempted to open the door several times to speak further but Emily blocked the door. Emily was advised at that time, while hiding behind the window of her living room, that warrants for obstructing would be filed. No identifying info could be gathered for Mickalah as she was not allowed to speak with Officers, and following the incident, ran away from the scene.

While viewing the video and advising Ms. Fudge that Officers did not have permission to search the residence, a family member of Ms. Everhart showed up to pick up her kids. Ms. Everhart exited the residence and was apprehended. Once grabbed by Officers, Ms. Everhart pulled away to evade arrest, and was taken to the ground by Officer Mefford. Once in custody and being transported to the jail, she complained of head pain and to be evaluated by medics.

Emily was then transported to Springfield Regional Medical Center where she was evaluated and discharged. Ms. Everhart was then taken to the Clark County Jail where she was held on charges of Obstruction, Resisting Arrest, and Contributing to the Delinquency of a Minor.
