The Affiant, Officer Spires, being first sworn, says there is probable cause to believe the defendant, Christopher R Jones, committed an offense based on the summary of facts below:

On 11/24/2025 at 2017 hours, I (Officer Spires) was working as the assigned information officer when I received a call from \_\_\_\_\_ regarding a criminal damaging complaint that occurred at 1001

..... advises that his father, Christopher Ryan Jones, put glue into the lock on his SUV door. His SUV is a black 2008 Ford Explorer \_\_\_\_\_ advises that he was able to fit the key in the door to unlock it, but it was hard, and there is crystalized glue that can be seen on the lock when looking at it.

Before \_\_\_\_\_ discovered the glue on his vehicle, his \_\_\_\_\_ and \_\_\_\_\_ had seen Christopher with glue in his hand at the address stating, "I am going to make sure he doesn't move this car." Christopher also texted \_\_\_\_\_ afterwards asking if Michael had seen the door lock being glued.

Mr. Jones was unable to provide any additional contact information or personal identification information for \_\_\_\_\_ other than the address

On 11/26/2025, Officer Schmidt and I (Officer Spires) followed up on this call by visiting the \_\_\_\_\_ house and speaking with the witnesses. When speaking with \_\_\_\_\_ they both advised they had seen Christopher Jones at their residence with the bottle of glue in his hand. \_\_\_\_\_ also advised that Christopher Jones said he was going to put the glue into the lock of the car. Neither witness observed Christopher Jones actually put the glue in the key hole but advised that later in the day, Christopher Jones sent a text to \_\_\_\_\_ asking if the victim had seen the glue in the key hole on his vehicle. We did obtain statements from the witnesses and photograph the damage to the lock on the vehicle. While we were at the residence, one of the witnesses, \_\_\_\_\_ attempted to put the vehicle key in the lock on the door but was unable to do so because of the glue.

A warrant is requested for one, Christopher R. Jones, for Criminal Mischief.
