



The Affiant, Deputy Amy Weiss, being first sworn, says there is probable cause to believe the defendant, Larry Thomas Price, committed an offense based on the summary of facts below:

BWCR 94

On December 5, 2025, Deputies responded to \_\_\_\_\_ in German Twp. for a domestic. Mary Vititoe reported \_\_\_\_\_ was choked and threatened to shoot her. Mary stated their father Bruce Booth was on his way to pick up \_\_\_\_\_

Upon arrival, Deputy Viol and Officer Hupp knocked on the door of \_\_\_\_\_, and received no answer. Deputy Viol and Officer Hupp then knocked on \_\_\_\_\_ knowing from prior calls, both of these residence belong to the same family. \_\_\_\_\_ answered the door and advised Officer Hupp and Deputy Viol of \_\_\_\_\_, Larry Price having a long gun, and lying on the couch in the residence of \_\_\_\_\_

I, Deputy A. Weiss took \_\_\_\_\_ from the scene and to safety at Willow Road and Snyder- Domer Road. A perimeter was then set around the property. Larry refused to come out of the residence.

I interviewed \_\_\_\_\_ who stated she and Larry had gone to Walmart earlier in the day. Larry had waited in the car. When \_\_\_\_\_ returned to the car, Larry was upset she took so long and he was outside in the cold. When both parties arrived to the residence, the argument escalated. Larry came up from behind \_\_\_\_\_, wrapped both hands around her neck and squeezed. \_\_\_\_\_ collapsed on the bed. Larry continued to apply pressure as he climbed on top of her back. \_\_\_\_\_ attempted to get away from Larry. \_\_\_\_\_ ended up rolling off the bed. Larry then began chasing \_\_\_\_\_ around the room, spraying her with water. \_\_\_\_\_ jumped on the bed in attempts to get away. Larry then grabbed a pistol and told \_\_\_\_\_ he is going to kill her. \_\_\_\_\_ attempted to grab her belongings, and Larry told her she wasn't going to do that. and that he would kill her if she did anything. \_\_\_\_\_ then ran outside and into the residence of \_\_\_\_\_ and called Mary.

I provided \_\_\_\_\_ with a lethality screening and a Marcy's law sheet. I then asked \_\_\_\_\_ about the strangulation. \_\_\_\_\_ stated it went on for approximately 15 minutes. \_\_\_\_\_ stated he continued to cuss her out and call her a bitch. \_\_\_\_\_ stated out of a scale between 1 through 10 on pressure applied to her neck, it was about and 8. \_\_\_\_\_ stated the pressure was consistent and she urinated herself. \_\_\_\_\_ stated she didn't lose consciousness but was feeling fuzzy. \_\_\_\_\_ stated she thought she was going to die. An advocate was contacted and transferred over to Sgt. Jone's phone. Sgt. Jone's then provided her phone to \_\_\_\_\_ to speak with an advocate.

SOT team responded to the scene. Negotiations officers responded to the scene. They began working with Larry in attempts to have him surrender. Larry continued to threaten law enforcement, stating several times he would shoot them if they approached or attempted to arrest him. Larry barricaded himself in the residence with a firearm for several hours. Negotiation teams and command

post where set up. After several hours, Larry final came outside willingly. Larry was taken into custody and charged with Strangulation, Domestic Violence, Assault, Obstruction of Official Business, Aggravated Menacing, and Inciting Violence. A CCH was conducted with results of no priors.
