

The Affiant, Deputy Billy Thomas, being first sworn, says there is probable cause to believe the defendant, Joshua Smith, committed an offense based on the summary of facts below:

On December 27, 2025 at 2355 hours, I was dispatched to the _____ in reference to somebody breaking out the back window to _____ 2012 Honda Civic bearing OH license KUV-5527. While on my way to _____ told the Clark County Communication Center that she just wanted a call from a Deputy to make a report. I called _____ and she stated that a man by the name of Joshua Smith broke out her rear window on her vehicle. _____ stated that she was giving Joshua a ride when she stopped at _____ to empty some trash out of her vehicle. _____ stated that Joshua got out of the vehicle when she parked, then stood behind the vehicle and demanded that she open the passenger door to let him back in the vehicle once she finished cleaning out the trash. _____ stated that she thought Joshua may attack her when she got out of the vehicle due to previous altercations with him and she refused to open his door. _____ stated that Joshua then stood behind her vehicle and began smacking the back window. _____ stated that she tried to move her vehicle and Joshua smacked the window again causing it to break. _____ said somebody in a red pick up truck stopped and spoke to Joshua and distracted him so she was able to back out of the parking spot and leave the area. I asked _____ where she was at currently and she stated _____. I advised _____ that I would stop out at her address after looking at the security footage in _____.

Once at _____ I spoke to the employees and they were able to pull up the security footage and the incident occurred at 2348 hours. In the video it showed that _____ pulled into a parking spot on the southeast corner of _____ and a male wearing a black hoodie and black pants stepped out of the passenger side of the vehicle. The male identified as Joshua Smith then walked to the rear of the vehicle leaning on the trunk so _____ could not back out of the parking spot. In the video, Joshua smacked the back window several times and began yelling at _____. Joshua would stop yelling when people walked by to go into _____ and once they were inside he began smacking the back window and yelling at _____. _____ then turned on her vehicle and put the vehicle in reverse. Joshua refused to move and smacked the back window again causing it to shatter. At this time, somebody in a red pick up truck pulled up behind _____ vehicle and said something to Joshua causing him to walk up to the passenger side of the pick up truck. When Joshua moved towards the pick up truck the video showed _____ back up and leave the area traveling southbound on _____. After _____ left _____ the video showed Joshua walking northbound on _____. Once I finished viewing the security footage, I recorded the footage with my body camera.

After viewing the security footage, I went out to _____ with Deputy Reynolds. I took photographs of the damage to _____ 2012 Honda Civic bearing OH license KUV-5527 while filled out a Witness Statement. After _____ filled out the Witness Statement, she showed us a photograph of Joshua Smith and we were able to confirm his identity through Clark County Communication Center. _____ also stated that Joshua knew a _____ that lived a _____ and Joshua was probably walking there when he left.

After speaking with _____ Deputies checked the 24 hour laundry mat at _____ for Joshua but he was not there. Deputies then tried to make contact with residents at _____ but nobody answered the door. After searching the area I went back to the substation to complete the paperwork, at this time _____ called back in to Clark County Communication Center for an update and wanted a call back. I called _____ back via the New Carlisle cellphone and she stated that Joshua also stole the title for her vehicle while he was sitting in the passenger seat. _____ stated that she was currently filing a lost/stolen title claim on the Ohio BMV website and I advised her that I would file paperwork for a warrant on theft also.

Paperwork will be completed to file for warrants on Joshua Smith for O.R.C. 2909.06(A)(1) Criminal Damaging, O.R.C. 2917.11(A)(1) Disorderly Conduct and O.R.C. 2913.02(A)(1) Theft.
