The Affiant, Conor Tait, being first sworn, says there is probable cause to believe the defendant, Brady Chase Satterfield, committed an offense based on the summary of facts below:

On 01/10/2026 at approximately 2046 hours, officers were dispatched to the area of _____, on a report of a white male standing in the middle of the roadway impeding traffic. Officers made contact with the male who was identified as Brady Satterfield. Mr. Satterfield was observed to be in the middle of the right hand eastbound lane of E. Main St. Upon contact he would not answer officer's questions as to who he was or why he was in the roadway. Mr. Satterfield then pulled a debit card with his name on it and stuck it out for officers to see his name displayed. Mr. Satterfield then took off three layers of clothing and began to stand on the sidewalk with no shirt on. I (Ofc. Tait) observed Mr. Satterfield's pupils to be significantly dilated.

Officers advised the male to stay out of the roadway multiple times. Officers asked Mr. Satterfield multiple times if he needed police assistance but he declined. Officers encouraged him to put his clothing back on as the temperature outside was frigid. He did not comply. Officers determined that nothing criminal had taken place and thus Mr. Satterfield was advised again to stay out of the roadway while officers left the scene.

Officer Bartlam and I then drove to a nearby parking lot and observed the male from afar in case he should return to the roadway. Within a few minutes Mr. Satterfield returned to the middle of E. Main St. impeding traffic and risking injury to himself and others. Officers returned to the area of the 1500 block of E. Main St. and took Mr. Satterfield into custody. Medics were summoned to the scene for the male to be transported to SRMC to be pink-slipped and evaluated.

While officers were waiting on medics to arrive, Mr. Satterfield stated that officers were "pussies" and then proceeded to spit or _____ chin, neck, and upper vest area. Officers immediately placed the male in the police van. Officers transported him to the Clark County Jail directly.

Mr. Satterfield is being charged with one count of Harassment by Intimate (ORC 2921.38B). He is housed in the Clark County Jail and has been provided a court date of 01/12/2026 at 1030 hours.


