



The Affiant, Officer T Young, being first sworn, says there is probable cause to believe the defendant, Joseph George Buck II, committed an offense based on the summary of facts below:

On 1-17-2026 at 2337 hours, I, Officer Young, was dispatched to : in reference to (victim) stating that Joseph Buck II (defendant) threatened her.

Dispatch advised that Mr. Buck told her he would beat her brains out.

Upon arrival, I spoke with She stated at approximately 2315 hours, she and Mr. Buck were in the upstairs front room of this address arguing. advised her and Mr. Buck have lived together at this address for 3 years, and have been dating for that period of time as well. She stated he began accusing her of being a prostitute and he became upset with her. She stated he told her that he would stomp her brains out. Mr. Buck then swung at her face with a closed fist with his right hand, attempting to punch her. She stated he missed her face, and then she left because she was scared.

stated he called 911 afterwards and then called her sister to have her come and pick her up. While speaking with she declined to provide a written statement and started walking away from me after Mr. Buck came outside, where I was speaking with her.

At 2346 hours, I placed Mr. Buck in custody. He was not cooperative with officers, and just kept stating he didn't do anything. He then began attempting to kick the partition of the police cruiser while on the way to jail. He was booked in the Clark County Jail.

Mr. Buck was charged with Assault, Menacing, and two counts of Domestic Violence.


