The Affiant, Off Harrington , being first sworn, says there is probable cause to believe the defendant, Uche David Uduhiri , committed an offense based on the summary of facts below:

On 01/16/2026 Officers Davis and Harrington were dispatched to _____, in reference to a protection order violation. Officers met with _____ who advised that their neighbor, Uche Uduhiri violated their protection order today.

_____ showed Officers a Protection order (_____ that protects _____ from Mr. Uduhiri. One of the lines of the protection order reads "Respondent shall not use any form of electronic surveillance on protected person". _____ then showed Officers photos that _____ took earlier today that shows a security camera on the southeast corner of 519 S Belmont, (Mr. Uduhiri's house). The security camera is pointed east of the house towards S Belmont Ave. A second photo then shows a ladder by the camera. A third photo later taken then shows the camera now pointed towards _____. Officers verified through dispatch that the protection order was served on 1/8/26 by Deputy Ballentine. Officers Bennett and C. Taylor assisted Officers Davis and Harrington in making contact with Mr. Uduhiri at 519 S Belmont Ave.

Officers made contact with Mr. Uduhiri at 519 S Belmont and read him his Miranda Rights, Mr. Uduhiri advised that he understood his rights. Officers advised Mr. Uduhiri of the situation and asked to see what the camera on the Southeast corner of his house could see. Mr. Uduhiri showed Officers the security camera view on his phone, and Officers observed the east side of _____, including the front porch. When Officers asked why Mr. Uduhiri moved his cameras today, he advised that he was trying to take the cameras down because he is moving soon. Mr. Uduhiri was unable to come up with a logical reason as to why he moved his cameras today. Mr. Uduhiri advised that he has a protection order against _____. Officers verified this protection order and that it reads the same as _____ Protection order in that "Respondent shall not use any form of electronic surveillance on the protected person". Officers observed two cameras on _____ property that appeared to be pointed towards Mr. Uduhiri's house.

Officers spoke with _____ and asked to see the view of their security cameras. _____ showed Officer Harrington the view of their security cameras by using her phone. Officer Harrington observed that both cameras are pointed down at the alleyway in between _____ house and Mr. Uduhiri's house. No part of Mr. Uduhiri's house can be seen on either camera.

Officers were unable to speak with _____ Directly.

Sgt. L. Harris took photos of the photos that were taken by _____ showing Mr. Uduhiri's cameras before and after being moved today.

Uche Uduhiri was arrested for two counts of Protection Order Violation. He was placed in Clark County Jail, Court on 1/19/26 at 1000 hours.
