**The Affiant, Officer Spires , being first sworn, says there is probable cause to believe the defendant, William James Buchanan , committed an offense based on the summary of facts below:**

On 01/16/2026 at 0942 hours, Officer McCutcheon and I (Officer Spires) were dispatched to 1600 N. Bechtle Ave. (Kohl's) for a theft in progress.

A loss prevention specialist, who was identified as \_\_\_\_\_ observed the suspect take off his shoes and put on a brand new pair of shoes and proceed to walk around the store with the new shoes on. He then observed the suspect - \_\_\_\_\_ pocketing a few items on his person and walk past all points of sale without stopping, exiting the store without paying.

Officers were able to see the suspect, who was identified as William Buchanan, exit the store without paying with a pair of shoes he put on in the store.

When Officer McCutcheon patted Mr. Buchanan down in the parking lot, he located another pair of brand new Nike shoes tucked into Mr. Buchanan's waistband and a pair of black underarmour shorts tucked into his waistband as well. 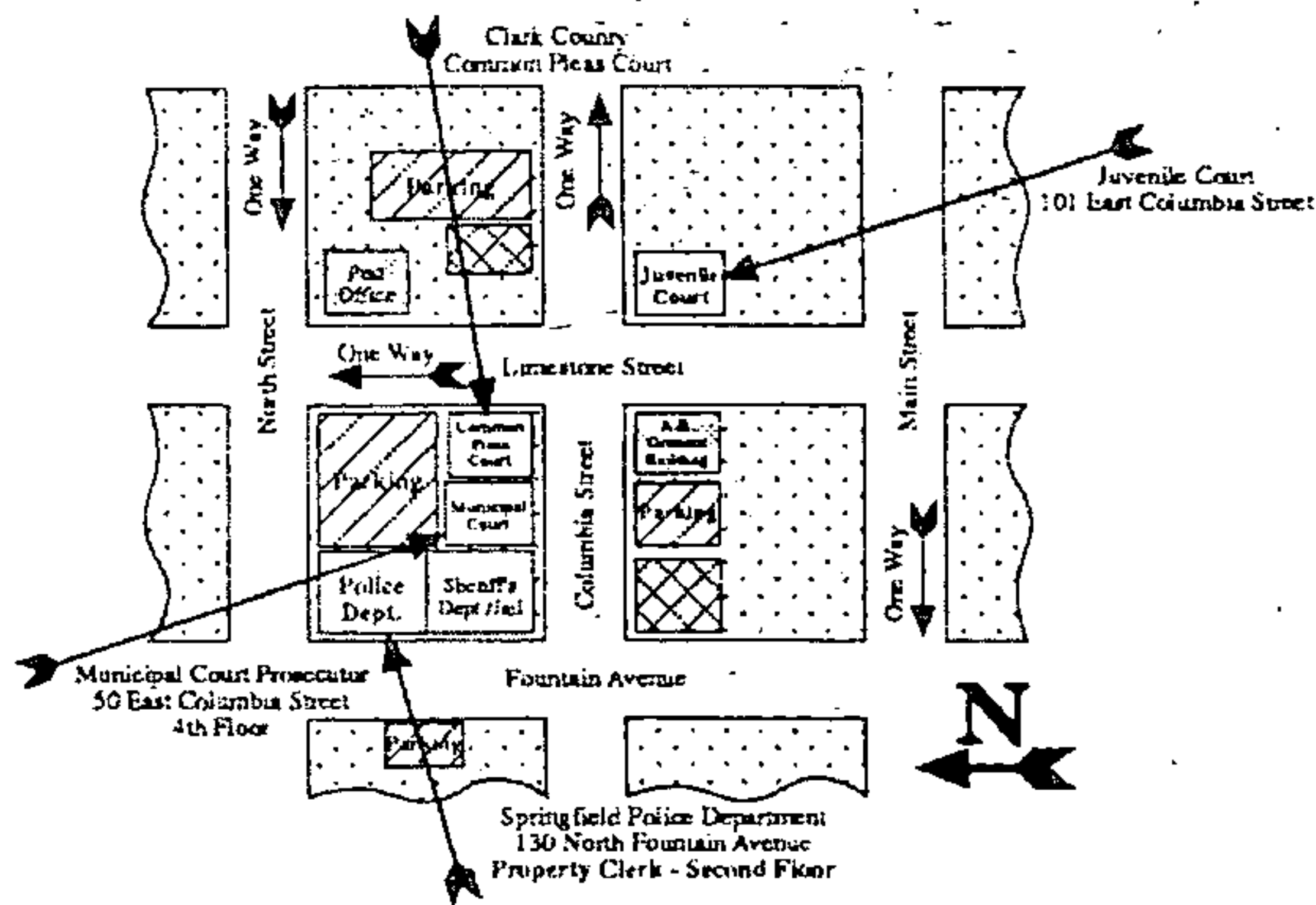
